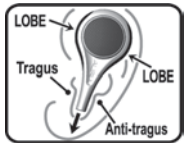

### Instructions of use:

#### XFit™ technology:

XFit is an ergonomically designed system, engineered to provide unrivaled comfort and a confident fit during all types of



activities. XFit system is based on highly ergonomic LOBES that gently slip over the soft, flexible portions of your ears – known as the tragus and anti-tragus.

These ultra-soft LOBES conform to your ears and keep your earphones in place even during your most vigorous activities.

#### How to use:

Place the (R) earbud in your right ear and slide downwards until comfortable, then do the same with the (L) earbud in your left ear.

#### Tip:



Place the earphones in your outer ear, pointed approximately towards your nose as shown and slide towards your mouth.



Then gently rotate the earphone down towards your chin until the earphones feel comfortable and snug.

### ECO (Ear Canal Opening) rings:

The ECO rings are an integral part of the XFit system and are designed to help position the speakers properly for maximum comfort and optimum sound quality. Some consumers may achieve the best fit and enjoy better sound quality, by using different sized rings for their respective earphones.



We have included four (4) different sized and shaped rings, which will enable you to individualize the fit based on your own ear shape and size.

**To remove:**  
Place fingernail under the Personalizer and lift.

**To replace:**  
Align and snap the Personalizer firmly in place.
